The Correspondent of Harvest Spring Leaf School, H No 7-300 Near Rajiv Gruhakalpa, Polepalli(v), Khammam (rural)(m), Khammam(dist) has submitted the proposals for grant of Renewal Recognition of classes VIII to X (E.M) (with one section) from the year 2022-23 to 2031-32.

The Mandal Education Officer, Khammam (rural), Khammam has verified the proposals with reference to the conditions laid down in the Recognition orders and GO Ms No 1/Edn, Dated: 01-01-1994 and subsequent Government Orders submitted a detailed report through the letter

After careful examination of the proposals of the Correspondent and report of the Mandal Education Officer, Khammam (rural), Khammam based on the recommendation of the District Education Officer, Khammam, the Regional Joint Director of School Education, Warangal is pleased to accord the Renewal Recognition of Classes VIII to X (E.M) (with one section) for a period of ten (10) years from 2022-23 to 2031-32 in respect of Harvest Spring Leaf School, H No 7-300 Near Rajiv Gruhakalpa, Polepalli(v), Khammam (rural)(m), Khammam(dist). The management is requested to follow the conditions.

1. The above Renewal Recognition is accorded purely on a temporary basis and is subjected to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre requisite condition under the A.P Education Act 1982 and if later found that the school has not fulfilled any pre requisites as stipulated, the Renewal Recognition now being given is liable to be withdrawn at any time.

- 2. That the society shall abide to the rules and regulations made in the Govt. Orders 1st cited and subsequent orders.
- 3. That the Society shall provide the necessary amenities like accommodation sanitary facilities, drinking water facilities, furniture, Library, Laboratory, equipment play field required staff as per the staff pattern another facilities.
- 4. That the Renewal Recognition is accorded to the Progressive Educational Society.
- 5. The Renewal Recognition is accorded to run the school in the locality and there shall not be any change in the premises of locality specified in the orders.
- 6. The management should follow the G.O.Ms.No.22, dated 18-07-2017 i,e., the weight of the school bag not to exceed 4kg for VI-VII,4.5 kg for VIII-IX and 5 kg for X.
- 7. That the administrative report and the audited statement of accounts of the school duly attested by the Chartered accountant for every financial year shall be submitted to the District Educational Officer, latest by September
- 8. The Management has to follow the government norms from time to time, for collection of fee from students.
- 9. That educational agency shall not use the premises building, play ground and vacant site belongs to the institution for any purpose other than the Educational activities and conducting authorized examinations without permission of DEO.
- 10. The management should follow the guidelines issued in G.O.Ms. No. 36., School Education (General) Dept., Dt:- 16-12-2017 for the safety and security of the children in the schools.
- 11. The management should pay the mandate taxes due to the concerned departments as per schedule fixed by the Government.
- 12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments
- 13. The school shall have 'first aid-kit' and the teachers shall be trained in first aid.
- 14. That any children studied in recognized school of other states/countries affiliated to the bodies recognized by the state or central government shall not be admitted without prior permission of the District Educational Officer/Director of School Education.
- 15. That the management shall not collect any fees or donations either in cash or kind other than the fees prescribed by the governing body from pupils or parents or any other person or on their behalf for any purpose.
- 16. That educational agency shall not force any member of the staff or students of the institutions to take part in the religious discourses and preaching of religion irrespective of whether they belong to the same belief or not.
- 17. If the Management provides transportation, it is the responsibility of the Management to submit Fitness Certificates of their buses every year regularly to the D.E.O. to have skilled, Trained, Licensed and healthy driver. If any deviation in this matter, they will be personally held responsible.
- 18. The Correspondent should submit Renewal of Recognition proposals before 90 days of the expiry of Renewal Recognition.

- 19. The Educational Agency should Implement the Guidelines for Safe and Effective use of Internet & Digital Technologies in schools and school buses issued by CBSE vide Circular No.Acad-32/2017, dated 18.08.2017 communicated by MHRD, Govt. of India.
- 20. The Educational Agency should Implement the Model Education Code prepared by National University for Educational Planning and Administration in 2015
- 21. That educational agency shall not permit the students of any D.Ed/B.Ed colleges or college of physical education or any teacher training institution to have teaching practice without the permission of the District Educational Officer.
- 22. Proper and adequate parking area for vehicles shall be provided transporting the children to and from the school.
- 23. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
- 24. The Parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children
- 25. The school shall constitute Committees for reddressal of the Public/ Staff/ Parents/ Students grievances, Internal Complaints Committee on Sexual Harassment and Committees under POCSO (Protection of Children from Sexual Offence) Act, 2012 and details of these Committees along with contact details shall be displayed prominently on School Notice Board and conspicuously on the School Website for the information of all the stakeholders.

- 04. The school timings, vacations and mid term holidays shall be as prescribed by Govt. from time to time.
- 05. That the qualified staff with in the age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern.
- 06. That the results of the institution shall be satisfactory every year.
- 07. That the records/accounts shall be furnished to the DEO every year by 30th September at the latest.
- 08. That the list of Governing Body shall be furnished to the DEO every year.
- O9. That the pay structure / fee structure fixed by the Government Body shall be got approved by the DEO every year and display the same in the school notice board.
- 10. That all the conditions prescribed in the G.Os and other orders which are not specified in this order shall be complied with.

- 11. That the school shall not be closed without giving notice both to the parents / DEO and competent authority at least 6 months before.
- 12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13. That the society shall submit proposals for Renewal Recognition sufficiently in advance i.e., at least 6 months period to the date of expiry of the permission.
- 14. The approval of the correspondent-ship should get approved by the competent authority.

15. EPF scheme should be implemented to all eligible staff.

 Next Higher classes / additional sections should not be opened without prior permission from competent authority.

17. Sufficient play ground, land for garden and library books shall be provided as per rules.

- 18. Proper and adequate sanitation facilities shall be provided for students especially for girls
- 19. Proper and adequate area for vehicles shall be provided transporting the children to and from the school.
- 20. Proper and adequate measure shall be taken for children with in the campus and also near the school premises.
- 21. The School Shall follow the Traffic and safety guidelines indicated by the Police and Fire Service Department.
- 22. The parent Teacher Association meeting shall be conducted to sensitize the parents on safety of the children.
- 23. The school shall have first aid kit and the teacher shall be trained in first aid.

24. That the lapse is found the permission will be withdrawn without any notice.

- 25. That the management shall collect the Professional tax from the teachers as per rates communicated to the Mandal Educational Officer for remittance in to the concerned Head of Account.
- 26. That the management should Renewal the fire NOC and submit the same within three months, otherwise permission will be withdrawn without any notice.
- 27. That the management should submit income and expenditure particulars every year to the undersigned without fail.
- 28. That the management will held responsible for providing of transportation and for further consequences.
